A host of individuals and youth volunteers who work tirelessly in different sectors of social development were shortlisted in the Volunteer of the Year and Youth Volunteer of the Year category. A distinguished national jury comprising Anshu Gupta, Founder - NGO Gooni, Indira Dasgupta, associated with Board of International Association of Volunteer Effort, Dr. Lalit Kumar, Secretary, National Foundation for Communal Harmony Ministry of Home Affairs & Joint Adviser (Voluntary Action) Planning Commission, Government of India and Sanjiv Kaura, CEO of the Corporate Social Responsibility division of Bennett, Coleman & Co. Ltd who serves a month every year as Lieutenant in The Territorial Army selected the proud winners of the programme.
